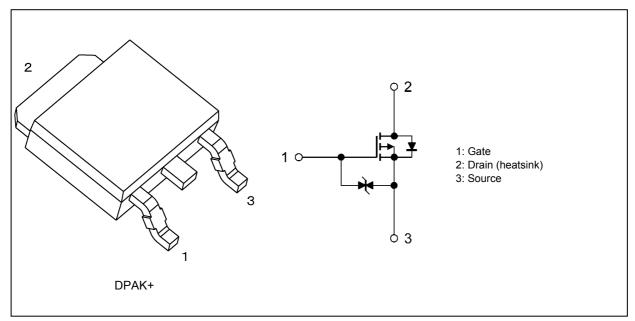






Fig. 7.1 Marking








Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.11 $P_D - T_c$ (Guaranteed Maximum)







Fig. 8.15 Test Circuit/Waveform
